PUBLIC NOTICE STRATHAM BOARD OF SELECTMEN

THERE WILL BE A PUBLIC HEARING HELD ON **MONDAY, FEBRUARY 13, 2017 AT 7:30 PM** IN THE STRATHAM MUNICIPAL CENTER, 10 BUNKER HILL AVENUE, CONCERNING THE TOWN OF STRATHAM 2017 TOWN WARRANT. SPECIFIC ITEMS TO BE DISCUSSED INCLUDE BUT ARE NOT NECESSARILY LIMITED TO THE FOLLOWING:

- 1. THE ADOPTION OF THE "ALL VETERANS' PROPERTY TAX CREDIT" AS PROVIDED BY RSA 72:28-b.
- 2. PROPOSED 2017 TOWN OPERATING BUDGET.
- 3. PROPOSED 2017 CAPITAL IMPROVEMENTS PROGRAM.
- 4. A SPECIAL WARRANT ARTICLE TO FUND THE PURCHASE OF A CONSERVATION EASEMENT
- 5. A SPECIAL WARRANT ARTICLE TO CREATE AN EXPENDABLE TRUST FUND FOR THE OBSERVANCE OF THE TOWN'S 350TH ANNIVERSARY, AND RAISE AND APPROPRIATE MONEY INTO SUCH A TRUST FUND.
- 6. A SPECIAL WARRANT ARTICLE TO FUND THE "EXPENDABLE MAINTENANCE TRUST FUND FOR THE CARE AND MAINTENANCE OF TOWN BUILDINGS AND GROUNDS."
- 7. THE FUNDING OF FIRE DEPARTMENT TRAINING, EQUIPMENT PURCHASE, AND ADVANCE LIFE SUPPORT SERVICES BY AUTHORIZING THE USE OF FUNDS FROM THE "STRATHAM FIRE DEPARTMENT EMS FUND."
- 8. A SPECIAL WARRANT ARTICLE TO FUND CONTRIBUTIONS TO THE "ACCRUED BENEFITS LIABILITY EXPENDABLE TRUST FUND."
- 9. RATIFY A POWER PURCHASE AGREEMENT BETWEEN THE TOWN AND REVISION ENERGY FOR A SOLAR PANEL PROJECT.
- 10. A PETITION WARRANT ARTICLE BY PETER WIGGIN AND OTHERS CONCERNING THE DISPLAY OF THE POW/MIA FLAG AT STRATHAM HILL PARK.
- 11. ANY OTHER SPECIAL WARRANT ARTICLES TO APPEAR ON THE 2017 WARRANT.
- 12. ANY OTHER PETITION WARRANT ARTICLES TO APPEAR ON THE 2017 WARRANT.
- 13. ANY OTHER ITEMS TO APPEAR ON THE 2017 TOWN WARRANT.

THE PUBLIC HEARING WILL BE CONTINUED TO **MONDAY, FEBRUARY 20, 2017 AT 7:30 PM** IF NECESSARY. THE NEED FOR THE CONTINUED HEARING WILL BE DETERMINED AT THE FEBRUARY 13, 2017 HEARING. THE STRATHAM BOARD OF SELECTMEN INVITES ALL RESIDENTS OF TOWN TO ATTEND THIS PUBLIC HEARING AND WILL BE PRESENT TO ANSWER ANY QUESTIONS.
