- 1.) Approve Meeting minutes from April 10 & May 8, 2018
- 2.) Solar Update @ Stratham PD
 - a. System up and running but is not "on" as Power Purchase Agreement (PPA) qualification for related tax credits are on hold due to ReVisions recent conversion from a B-corp to an employee owned organization. This complicates matters as it changes ReVisions's qualification per the tax code, eroding nearly half the ROI value of PPA. ReVison trying to package multiple small PPA packages together inclusive of the Stratham PD installation – as a workaround to achieve the ROI via a bundled instrument. This has served to delay turning them on also delays ROI
 - b. Nuances on snow issue / safety matter / mitigation. None are mutually satisfactory to both parties. Of these, the idea to stagger the install to ReVision as in -place mitigation to be proposed by Paul Deschaine.
 - c. Paul is following up with Jack from ReVision and with Chief Scippa to find a resolution.
- 3.) Update on Lighting Project
 - a. Full detail from Unutil received (lights, counts, pole number, light type, street location, wattage).
