1. Call to Order

2. Review/Approval of Meeting Minutes

3. Public Meeting

a. Presentation by N. Merrill and L. Cushman on history of the Gateway District. Idea is grounded in past Master Plans. Stratham experienced tremendous growth in late 70's and through the 80's. Circa 2000, Town focused on land conservation and protection. About same time there was realization of growing tax burden. Residents wanted relief through more commercial development but did not want to expand the area of the commercial zone. Gateway Committee worked from 2007 through 2010, was an intensive process with public involvement. Results included support for expanding the tax base, mixed uses, affordable housing, connection to conservation land. Presentation was followed by

1 Committee discussion. Question raised concerning the relevance of the history to today's 2 understandings and perceptions. 3 N. Merrill, left meeting at 8:06PM. 4 Some believe goals have not changed – lower taxes, more commercial development, 5 provide employment opportunities and affordable housing to allow youth to grow and 6 stay in Town, and aging population to remain in Town. Further discussion of expectation 7 to keep the status quo (current provisions for private water and sewer, current type of 8 development, current tax rate) and is this possible with land areas approaching build-out. 9 b. Presentation by John Boisvert, Chair of Public Works Commission. Commission was 10 initially tasked with studying the issue of large groundwater withdrawals proposed by 11 Aquarian and Golf Club of New England. Next began investigating provision of water 12 system for fire protection in commercial zone. Realization that public water and sewer 13 utilities are needed to achieve the desired development density in the Gateway District. 14 Explored water sources. Fire protection drives the cost of the system more than demand. 15 Further discussion of how quickly Town could expect development to grow if water and 16 sewer are installed. Predicting the pace of development is difficult. Discussed Exeter's 17 capacity to treat additional sewage load and additional capacity to supply water. Also 18 discussed the basis of the negotiated water connection fee (\$2m is based on ratio of 19 anticipated percent usage applied to capital cost of improvements). Commission could 20 not reach agreement with Exeter on a sewer connection fee. The estimate of \$18 for 21 water-sewer improvements was derived from various engineering studies. Engineering 22 estimates are typically conservative (on the high side). Discussed other similarly situated 23 communities that provided water & sewer. Bow cited as an example. 24 25 26 4. Next Meeting 27 The next meeting will be on March 23, 2017 at 7:00. 28 5. Adjournment 29 L. Cushman made a motion to adjourn at 9:07 pm. Seconded by M. Stowell.
