- The Application deadline is the soonest an application may be heard by the Board, however depending on the volume of applications, submittal by the deadline does not ensure being heard on the advertised public hearing date. No new agenda items will be heard after 10:00 pm subject to the discretion of the Planning Board Chair.
- All applications are reviewed in the order received and will be reviewed within the statutory time requirements.
- Applications that require review by the Conservation Commission may be placed on a later meeting date to ensure an adequate time period for review and comment by the Commission.
