- I. At 7:03pm Allison called the meeting to order.
- II. Members in attendance: Allison Knab, Casey Jurevic, Ryan Gurette, Catlin Middaugh, Jessie Hook

Guests: Seth Hickey Parks and Rec Director
- III. Consideration of Minutes from previous meetings: Casey made a motion to approve the August minutes as written. Jessie seconded the motion. All in favor, approved as written.
- IV. Treasurer's Report: Ryan reported on current finances. Expenses up this month due to summer camp expenses coming in. Senior community trips have lost money. Rec Desk yearly charges need to be checked.
- V. Report of the Stratham Parks and Recreation Director
 - a. Senior Programing-going well, programs selling out.
 - b. Soccer- Has begun. 5/6 numbers are low. K-2 numbers are strong. First Saturday went well.
 - c. Rec Desk App- Zach and Seth sat in on demo for Rec Desk app. Looking to step away from Team Snap. Half the price of Team Snap. Current Team Snap contract ends in July.

- f. Stevens Park- Still looking at adding a pavilion, not adding bathroom due to cost.
- g. Teen coordinator position- Has been reposted.
- h. Purchase request memos-
 - Portable Soccer goals- The Soccer Board would like to purchase two portable soccer goals. Money would come out of soccer fund, they have almost \$28000. Allison made a motion to purchase two 3 x 5 kwik Goal Goalazo Portable soccer goals not to exceed \$800. Casey seconded, all in favor.
 - Tarps for Babe Ruth field- Request to purchase 2 tarps to protect pitching mound and minimize erosion and reduce ongoing maintenance requirements. Allison made a motion to purchase 2 18' wind weighted tarps not to exceed \$1,700. Ryan seconded, all in favor.
 - Fall baseball field usage-Great Bay Baseball 8U is asking for the field for use fee to be waived for fall ball practices. Team includes Stratham kids and is coached by a Stratham parent. Ryan made a motion to waive the cost of field rental for Great Bay fall baseball program. Jessie seconded motion, all in favor.
