- I. Call to Order: 7:04 PM
- II. Roll Call: Kate Dardinski, John Singleton, Trish Weideman, Seth Hickey.
- III. Consideration of minutes from previous meetings: Approval deferred (lack of quorum).
- IV. NEMBA discussion of multi-use trails

Keith Baker: Cooperation on trails, there is not animosity among mountain bikers and dog walkers. Code of conduct exists with trail etiquette - starting with Kingdom Trails with a program called "Ride with Gratitude". Sharing the trails with other users. Reminder to yield the right of way. Will attend the seacoast NEMBA chapter meeting to share some ideas. Seth: 3 kiosks have been constructed and will include a map and information. There will be an approval process in terms of what the 'campaign' will look like. Seth shared that we may consider having a bell program to alert other trail users to approaching riders. Are there other case studies out there that have worked? Are there suggested group sizes for rides? Keith: some unaffiliated groups will still come together but we can make recommendations in terms of sizes. Discussion of classification of E-bikes and potential impact on trails.

- V. Kiosk update: Cedar lumber will be used as base material rather than pressure-treated. Construction completed. Discussion with DPW to determine how to install at each location (Jack Rabbit, Long Hill, Scale House). Concerns by other groups/Select Board about what will be communicated on each kiosk. Use of QR codes to provide additional mapping information discussed.
- VI. EcoCounter update: Jack Rabbit counter is damaged due to water/freeze/thaw-out of warranty. Seth is working with vendor and town officials for replacement, hoping the vendor will honor 30% discount.
