## SHP TRAIL MANAGEMENT ADVISORY COMMITTEE DRAFT MINUTES Wednesday, September 3, 2025 7PM

- I. Call to Order: 7:03 PM
- II. Roll Call: Kate Dardinski, Bill McCarthy, John Singleton, Robert Keating, Trish Weideman, Edie Barker, Seth Hickey
- III. Consideration of minutes from previous meetings: Approved.
- IV. E-bike policy discussion: Increased use of e-bikes has been documented. Out-of-class bikes use increased, like “dirt bikes”. Committee recommends Class 1 e-bikes only (pedal assist only, top speed 20 mph). Parks and facilities in surrounding areas seem to be successfully using the restriction of Class 1 bikes only. Seth Hickey made Select Board aware of the need for ordinance. TMAC recommends and supports the limitation to Class 1 e-bikes only.
- V. Signage review: New kiosks in place. Signage on kiosks installed; recommendations for content changes will be explored in the future.. New 4x4 posts have been erected on public land; installation on private property targeted for November. Sample trail marker sign shared. Different colors will designate public and private properties.
- VI. Update on trail projects: 2 bridges replaced on Lovell Trail (Sig Sauer corporate community-service project). Discussion about potentially replacing bridge under power lines. Rivendale bridges need repair/replacement; application of traction strips has been completed. Conservation Commission consultation for all projects.
- VII. Community Resource officer update: Seth Hickey updated activities of the officer. Invitation to attend future TMAC meetings will be sent to the CRO.
