Seth Hickey provided an update on the Open Space project with FB Environmental. The goal is to produce a highly useful document like the Master Plan. The theme is a desire for Stratham to become more pedestrian and cyclist friendly.

Tim Copeland asked if there were some aspects that would require funding such as sidewalks. Seth Hickey responded that there are no specific directives rather the content is guidance on what options may be available.

Parks and Recreation will be installing a second Eco Counter at Stratham Hill Park. The location will likely be near the Scale House to gather data on traffic from the Main Lot.

On April 3<sup>rd</sup>, the new parking ordinance went into effect and new signage was posted. Stratham PD will initially focus on educating the public with windshield notices.

TMAC is supporting a science project from SMS looking at trail erosion. The project includes some collection devices that will be out on the trails for a short period of time.
