- 1.) Approve Meeting minutes from May 9th, 2017.
  - a. Minutes approved
- 2.) Solar Update Police station
  - a. Paul Deschaine is reviewing contract language with legal counsel and Revision Energy staff. Reviews continue on engineering design. Based on current workload and review process expectations, project completion expected in early Fall.
  - b. Unitil has conditionally approved the project and has put into the project queue for interconnection.
- 3.) Other Solar DPW lot to be repaved this fall. If ground mount solar system to be sited at or near Stevens Field, conduit would need to be laid under paving surface if looking to bury electrical lines for interconnection.
  - a. Mike W to work with Revision staff to look at feasibility of system and interconnection.
- 4.) Smart Solar Event UNH Law workshop in Concord on 6-22 to review ground mount solar siting issues.
  - a. No SEC members plan to attend.
- 5.) Energize 360 New community-led program focusing on investment in efficiency and solar installations at the residential level. Regional group of 5 towns, with 8 more expected to participate, that leverages group buying discounts to make participation more attractive and streamlined to customers. Pricing for services were bid out and are made transparent for interested parties.
  - a. Stratham will be represented by Charlie Case.
