Tote Road resurfaced end-to-end trail entry points. Post-workday Seth experimented with an infield mix and worked satisfactorily—set up well, drained well. Pre placement of large rocks/wood chips worked out very well. Sourcing of materials needs to be considered in future projects to ensure appropriate amounts of materials are obtained/used.
- V. Upcoming Trail Day: Saturday, November 6th (lower Kitty Rock)  
  
Workday: Scheduled for November 6: Lower Kitty Rock. Goal to improve drainage in lower areas. Historic trail will be kept open with clean up; alternate Kitty Rock trail will be better defined and drainage addressed, including removal of old water bars and installation of new water bars (5) using conveyor belt material. Seth has met with the Conservation Commission to review plans. Meeting with Allison Nab of the Conservation Commission on Thursday, November 4<sup>th</sup> to review plans.
