I Basketball Program

- * Programs Seth reported that the Ski Programs registrations have been strong, even with parents having to provide their own transportation; new programs include coding and online gaming; Seth said the Recreation Department will be offering some sort of summer camp program, he just isn't sure of the format or location yet; other programs which will be offered include spring Baseball/Softball, street hockey, and a cross-country series.

- * Stratham Hill Park Seth said the pump track needs some work and may need a major overhaul in the spring.
- * Smyk Park Seth stated that he is looking for creative ways to utilize Smyk Park and is considering a disc golf course as an option.
- * SkatePark Seth reported that the SkatePark Committee isn't going to take any major action in 2021.
