THERE WILL BE A PUBLIC HEARING HELD ON MONDAY, FEBRUARY 11, 2019 AT 7:30 PM IN THE STRATHAM MUNICIPAL CENTER, 10 BUNKER HILL AVENUE, CONCERNING THE TOWN OF STRATHAM 2019 TOWN WARRANT. SPECIFIC ITEMS TO BE DISCUSSED INCLUDE BUT ARE NOT NECESSARILY LIMITED TO THE FOLLOWING:

- 1. PROPOSED 2019 TOWN OPERATING BUDGET.
- 2. PROPOSED 2019 CAPITAL IMPROVEMENTS PROGRAM.
- 3. PROPOSED FUNDING OF CERTAIN CAPITAL RESERVE FUNDS FOR 2019.
- 4. A SPECIAL WARRANT ARTICLE TO FUND THE ACQUISITION OF TOTES TO FACILITATE AUTOMATION OF THE CURBSIDE RECYCLING AND TRASH COLLECTION PROGRAM.
- 5. A SPECIAL WARRANT ARTICLE TO FUND THE "EXPENDABLE MAINTENANCE TRUST FUND FOR THE CARE AND MAINTENANCE OF TOWN BUILDINGS AND GROUNDS."
- 6. THE FUNDING OF FIRE DEPARTMENT TRAINING, VEHICLES, EQUIPMENT PURCHASES, AND ADVANCE LIFE SUPPORT SERVICES BY AUTHORIZING THE USE OF FUNDS FROM THE "STRATHAM FIRE DEPARTMENT EMS FUND."
- 7. A WARRANT ARTICLE REGARDING ADJUSTMENTS TO INCOME AND ASSET THRESHOLDS FOR ELDERLY EXEMPTIONS FROM PROPERTY TAX.
- 8. A WARRANT ARTICLE TO CONSIDER CHANGING POLLING HOURS FOR TOWN AND STATE ELECTIONS.
- 9. ANY OTHER SPECIAL WARRANT ARTICLES TO APPEAR ON THE 2019 WARRANT.
- 10. ANY OTHER PETITION WARRANT ARTICLES TO APPEAR ON THE 2019 WARRANT.
- 11. ANY OTHER ITEMS TO APPEAR ON THE 2019 TOWN WARRANT.
